BOD RESOLUTION NO.13 S.2018

“RESOLUTION TO CREATE AND APPROVED POLICY TO ALLOW TWO METER CONNECTIONS IN ONE HOUSEHOLD”

WHEREAS, it is the policy of the district to strictly adhere for one meter one household policy and it has been implemented for years;

WHEREAS, there were few cases that this policy is not applicable particularly to households having an extended family/couples;

WHEREAS, to properly deal and resolve the issue a policy was created with certain conditions and provisions to be observed accordingly to continually deliver excellent and good services:

- ✓ Application for meter B connection in one household is allowed on occasion that meter A account owner will not allow his/her meter to be utilized by the new occupant provided that;
- ✓ Meter A account owner fully settled his/her bill;

WHEREAS, for instances that meter A account owner waived his/her rights and the new occupant assumes the same accounts with existing bill balance, he/she is allowed to partially pay the fifty percent bill to avail and make use water service connections;

WHEREAS, the remaining fifty percent will be paid in staggered basis for a period of four months in addition of the current bill incurred;

WHEREAS, failure of the concessionaire to settle accounts within the prescribe period, the district will restrict the service without prior notice.

NOW THEREFORE upon motion of Dir. Merly P. Abiva and duly seconded by Dir. Laudita J. Arapan be it-

RESOLVED AS IT IS HEREBY RESOLVED to Create and Approved Policy to Allow Two Meter Connections in One Household.

RESOLVED FINALLY that this resolution be furnished to all concern for their information and guidance.




