**BOD RESOLUTION NO.08-S.2020**

**“POLICY FOR COMMERCIAL ESTABLISHMENTS CLASSIFICATION WITH THE STANDARD WATER RATES FOR BUENAVISTA WATER DISTRICT ”**

SECTION 1 This policy will serve as a guiding principle for Buenavista Water District in the implementation of the standard and updated water rates for all commercial establishment classifications;

SECTION 2 All commercial establishments will be classified accordingly based on the nature of the business and with the start-up capitalization;

2.1 Commercial/ Industrial 2.0 – Large scale business establishments who directly or indirectly uses water in their day to day operation

2.2 Commercial A-1.75 - Business establishments who indirectly uses water in their day to day operation

2.3 Commercial B -1.50 - Small business establishment who indirectly uses water in their day to day operation with start-up capitalization of P25, 000 –up

2.4 Commercial C -1.25 - Small business establishment with or without permit to operate with a start-up capitalization of not more than P 25,000.00

SECTION 3 These are the sub-classifications of commercial class with assigned classification conversion definition factor:

**Commercial/Industrial 2.0**

- Rest Houses
- Hotel Lodges and the like
- Hospitals
- Cafeterias managed by Cooperatives and Corporations
- Beer Houses, Bars, Night Clubs, Disco Pads
- Restaurants, Carenderias
- Theaters
- Confectionaires, Bakeries
- Ice Plants
- Boarding Houses
- Mall
- Gasoline Stations
- Bus Station and Terminals
- Private Schools
- Cockpit, Billiard hall and other games and entertainment places
- Any residential places who sells or supplies water to others (individual name)

**Commercial A 1.75**

- Photo Services
- Dental and Medical Clinics including animal clinic
- Warehouses
- Groceries
- Gift Shops
- Drug Stores
- Wholesale and Retail outlet
- Fish and meat stall with individual water meter
- CHB and concrete product manufacturers
- Apartment whose owners assume payment of water bills using one central water meter
- Water Refilling Stations
- Banks, Pawnshop, Hardware

Commercial B 1.50

- Mini-groceries
- Carwash
- Dry Goods store
- Other premises utilized for selling foods or services including premises used for living quarters

Commercial C 1.25

- Offices excluding government offices
- Furniture shops
- Beauty parlor and Barber shop
- Funeral parlor
- Tinsmith
- Fruit stand
- Flower shop
- Internet shop
- Sari-sari store
- Motorcycle shop and Display center
- Vulcanizing and repair shops


SECTION 4 Business establishments will be notified thru letter of reclassification for their information and guidance.
