BOD RESOLUTION NO.06-S.2021

“POLICY REQUIRING CONTRACTORS WITH CONSTRUCTION PROJECTS AT BUENAVISTA, AGUSAN DEL NORTE TO APPLY FOR TEMPORARY WATER METER CONNECTION AT BUENAVISTA WATER DISTRICT”

WHEREAS, the purpose of this policy is to standardize and define goals of the District exclusively for construction firm owner/operators/contractors;

WHEREAS, construction firm is a business enterprise concerned with the construction of buildings, houses, etc., and other civil engineering related works;

WHEREAS, these are the definite procedures and guidelines to be observe in the implementation of this policy:

1. All contractors with construction projects in the municipality of Buenavista is required to apply at BWD for a temporary water meter connection with an application fee of P 3,000.00
2. After the construction, WM registered in the name of the construction firm/operator will be temporarily deposited in the BWD office and at anytime be utilized for other future projects in the municipality
3. In case the owner of the building will apply for water connection and will be utilized for construction purposes whether for residential or commercial buildings they will be charge for bulk water rate
4. After the construction, WM registered under the name of the building , it will be spontaneously change either for residential or commercial classification with its' corresponding water rate


NOW THEREFORE upon unanimous decision and approval of the August Body be it-
