## “POLICY TO ADOPT AND IMPLEMENT INCREASE FOR SERVICE CONNECTION FEES FOR COMMERCIAL B, INDUSTRIAL AND LARGE INDUSTRIAL ESTABLISHMENTS”

WHEREAS, commercial establishments are those establishments that engage or carries on any business or commercial purposes but does not include a multi-permanent, temporary dwelling place and permanent / residential area;

WHEREAS, all commercial establishments classification/categorization are based accordingly on the nature of the business and with the start-up capitalization of said establishments (sec.2 BOD Resolution No.08-2020);

WHEREAS, commercial establishments should be excluded from the standard application fee charges and therefore concur to increase application fee exclusive for commercial establishments only;

**NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED**, upon unanimous motion, the august body agreed to approve Policy to adopt and implement increase for service connection fees for Commercial B, Industrial and Large Industrial Establishments and these are the new application fees for the following establishments:


- a. Commercial B - P 4,000.00
- b. Industrial Connection - P 4,000.00
- c. Large Industrial Connection - P 5,000.00

RESOLVED FINALLY that this policy should be properly disseminated to all concerned concessionaires for their information and guidance and will take effect on March 2023.
